## 3. Matters Arising

**The Mad Hatter event** was held in September 2016 as a thank you for volunteers. Pam Baird suggested that the next time there is a Thank You for volunteers that it be promoted as such.

Annaliese rang with apologies – there is more work done on the Okana Trail asap and wants John Stroh to be able to continue weeding – cost half a day \$250 or full day \$324. Chair is to talk with Anneliese re completing a Project Brief and budget for the funding needed which will then be applied for once paperwork is sorted.

## Oscar Programme

The Secretary gave an update of where things were at:

Both interested parties who had sent in their CVs have been contacted and have both still expressed an interest. Secretary is going to contact them and propose an informal meeting between them (facilitated by Secretary) to see whether there can be movement together in this plan.

The Report for the Oscar Programme is available for the community to read – it is held in the Library at the Service Centre. This has been advertised on the Trust website and Face Book page.

Alison Evans said that it was necessary to keep the school (Christian) in the loop with what is happening. The house on the school grounds may still have room available however a couple of the rooms have already been rented out.

Bonnie Schenkel has spoken with Christian about this and he is still keen. The Chair is to arrange a time to visit and speak with Christian.

Bonnie also wondered about using the hall as a suitable venue however Alison Evans stated that as it is owned by the City Council there is no facility to be able to run a business from the premises.

Another venue raised was the Ju Jitsu rooms – however these would not be up to code

## 4. Representations

Don Babe and Craig Mason from the Little River Rail Trail Trust gave a talk briefly outlining the work that is being done at present. Their vision is that there will be a round trip on the trail from Selwyn to the central city which will pick up most tourist spots in Christchurch. It is possible to do in one day or even a 2 to 3 day round trip. Suggested that it could be great advertising for the Little River area and that it could be in the Trust's interest to promote this. The Rail Trail has been deemed "A Great Ride" by the council.

They are asking for the Trust to get behind them and support this going forward to enable traction with the Christchurch City Council. The CCC is needed to give consent for the use of paper roads.

Geoff Marks asked what it may require from the Trust – they are looking for backing, possibly a letter in support, also to be able to use the Trust name? They believe it is very important to get the local people on side. At present the CCC is busy with 13 other rail trails that are being developed.

Pam Baird asked about whether the Haaglund Ride was still an option – Craig said that it was but also the possibility of a helicopter lift.

There was mention of the possibility of conflict of interest between walkers and bikers. Donald Matheson inquired as to whether there had been contact with the Rod Donald Trust. It was also mentioned that there should be consultation with the Community Board.

The Chair asked for more detailed description ie maps so we can be clear where these trails go and for them to send us further information for The Trust's consideration.

## Bruce King – The Coronation Heritage Garden

Bruce has been looking after the Coronation Garden.

The Coronation Heritage Garden evolved through a group of people including myself (Bruce King) developing gardens on top of the two septic tanks outside the Little River Craft Station, the old Railway station.

While walking past the Coronation Heritage Garden site and despairing at its untidy and uncared for appearance, then observing photographs in the Little River museum, in the Craft Station, of when the memorial gates were first opened in 1923. From here it was apparent there was a desire and a need to beautify this very important landmark. Twenty six local folk had died in WW1 and six in WW2 - the ultimate sacrifice.

The Trust has funded \$400 towards expenses – plants, sprays in the past. Bruce wanted to personally thank the Trust for this and ask whether a similar donation could be made towards the costs of further planting etc.

Bruce also suggested that he would like to involve the local school and pre school in the planting programme.

The Treasurer is to work out funding options and respond to Bruce King in due course.

## Wasp Eradication:

Alison Evans has a presentation to share at the next meeting and she will also bring along a Pest Control Officer. A representative from Akaroa will also be invited.

Alison would like to apply for funding through the Rata Foundation – this funding is available all year around if under \$20,000 (Geoff Marks supplied this information)

Fiona Nicholl is to assist Alison with putting together a strategy going forward

(Treasurer noted that the last payment for traps was \$391.00 in January 2015)

#### More Trustees needed:

As Pam Baird has resigned as Trustee, there needs to be a replacement sought.

#### **Trailer Bookings:**

Donald Matheson queried how to handle money coming in from the trailer bookings – Treasurer is to supply an invoice/receipt book for this purpose

It was mentioned that the Registration for trailer is due - Treasurer to follow up

## **Birdlings Flat Kitchen:**

Geoff Marks gave an update regarding having a "commercial" kitchen in the build. The cost is \$700 annually to register with CCC with an ongoing \$600 monthly to keep registration up to date.

The kitchen needs to have benches and appliance surfaces that are smooth, impervious and easily cleanable.

There needs to be suitable handwashing facilities providing hot water, soap and disposable towels for hand drying.

This information will be relayed by Bonnie Schenkel to the Birdlings Flat Build Committee at their meeting on 8<sup>th</sup> November 2016 to enable them to make a decision in this regard.
