# 6. Matters Arising

## Letter from Don Babe/Craig Mason re Rail Trail

Discussion took place about the information in the letter received from Don Babe and Craig Mason

#### Two separate issues:

#### **Catons Bay**

- Glynis Dobson concerned with the Catons Bay area and would like a structure put in place to look after the property
- \$40,000 was put into Catons Bay
- Tom Dobson (involved with Corrections) had a gang that he supervised who planted and put a pathway in down to the lake and has continued working there spraying etc
- Since then has fallen into the void CCC/DOC not interested in keeping it up
- There needs to be a formal arrangement and someone to take management of the area is the Trust interested in taking on this project?
- Craig Mason has requested support from the Trust in this area
- Mario Downes mentioned a local who is looking for community service in the area and the question was raised whether the upkeep of Catons Bay could be part of this
- Other areas were mentioned that need tidying up and looking after the Memorial in Pa Road and the pump track
- Is this something that the Trust could look at getting involved with?

#### **Another option:**

There is an opportunity on the Peninsula to lead this project across the region to eventually get contracts and give an opportunity for local people to do local work.

This would work in with Marcus Puentener's idea of The Banks Peninsula Community Development Trust - a social enterprise start up group promoting and developing a more sustainable Banks Peninsula economically, environmentally and socially.

#### Action:

Mario Downes (Vice Chair) will attend to the matter of community service and how it might work within the area and report back to the Trust with information at the next meeting.

#### **Rail Trail**

Craig Mason lived in this community for 16 years and was the driver to get the Rail Trail through to Little River. He is prepared to carry on with this fight to get it through to Diamond Harbour – this would be great for Little River – increase patronage and be great for businesses.

The original Trust that was formed is going to be disbanded and therefore Craig Mason is looking for support from the community to continue with the Trail.

#### **Resolution:**

That the Trust will write a letter to the Rail Trail Trust – establishing contact with Craig Mason and Don Babe, advising that the Trust support the care of the Caton's Bay area and the principle of the continuation of the Rail Trail in the future.
